If my spouse does not survive me or if he/she fails to qualify or, if having qualified should die, resign or become incapacitated, then in that event I nominate and appoint _____ of _____ _____ as successor Personal Representative of this will and as trustee of my trusts created by this will, with all the powers and duties afforded my Personal Representative herein.

I direct that no Personal Representative or Trustee nominated and appointed by me shall be required to furnish any bond or other security for the faithful performance of his or her duties, notwithstanding any provision of law to the contrary.
