Message from Sadr Ansarullah, USA

Regarding financial sacrifices Allah says in the Holy Qur'an: "Surely my Lord enlarges the provision for such of His servants as He pleases and straitens it for such of them as He pleases. And whatever you spend, He will replace it; and He is the Best of providers." (The Holy Qur'an 34:40).

Allah also says in the Holy Qur'an: "The similitude of those who spend their wealth in the cause of Allah is like the similitude of a grain of corn which grows seven ears, in each ear a hundred grains. The Promised Messiah (peace on him) says: "It is impossible that you love Allah and at the same time you love your property. You can love only one. Lucky is he who loves Allah. Therefore, if any of you spends in the way of Allah, Allah will prosper his property more than the others. This is so, because property is not achieved by itself; rather it is bestowed by Allah."

Qa'id Mal

Majlis Ansarullah, USA provides subsidized MTA system for members who cannot afford to purchase the system on their own. The majlis pays up to 50% of the system's price. The member who needs this subsidy should send a request through local za'eem to qa'id ithar. The request should include proper address and telephone number

of the member. If the request is approved, qa'id mal will send payment to the vendor who will then ship the system to the member. Za'eem majlis is responsible for determining whether the member is deserving for the subsidy. In case a member cannot afford even half of the system's price, it will be considered as a special case by Sadr sahib.
