

SAMPLE 1

This sample applies to you if you are:

- (a) An Ahmadi Muslim;
- (b) of Pakistani origins;
- (c) living in the U.S.;
- (d) in valid immigration status in the U.S. (e.g. Permanent Resident);
- (e) not in possession of a valid Pakistan Passport; and
- (f) in possession of a non-U.S. Passport with at least two blank pages valid for at least 6 months after your proposed arrival date in India and;

Please make sure that you can answer YES to (a) – (f) before proceeding with this sample. If you answer NO to any of (a) through (f), please use a different sample.

This sample is composed of every screenshot of the entire Indian visa application process and the answers selected. We have redacted personal information. Each step of the application has been carefully detailed with accompanying instructions and screenshots of what to fill and how to fill in the form.

You must complete a total of 3 different Applications. They are:

1. **INITIAL CKGS APPLICATION:** The Indian government uses an outside vendor named GKGS (Cox & Kings Global Services) to collect and aggregate all Indian Visa applications. All applicants must first fill out the CKGS application at <https://www.in.ckgs.us/>.
2. **INDIAN GOVERNMENT ONLINE VISA FORM:** Once you complete the CKGS application, the CKGS website will redirect you to the Online Visa Form at the Indian Government website, which you then must fill. If you need to go to this site to resume filling out this part of your visa application, you can go to the website <https://indianvisaonline.gov.in/> and select the Tab located in the lower left hand side of the screen and titled For Regular/Paper visa by Indian Mission/Post, Apply here.
3. **FINAL CKGS APPLICATION AND FORMS:** Once you complete the Online Visa Form at the Indian Government website, the Indian Government website will redirect you back to the CKGS website to fill out further details.

SOME USEFUL HINTS BEFORE YOU START FILLING OUT THIS APPLICATION

- This is a lengthy application and could take up to three hours to fill in its entirety.
- The Indian Government has designed this application to glean and gain knowledge of any connections you, the applicant, hold with Pakistan. Accordingly, the application form changes based on you answers. But do not be concerned, as this guideline will help you fill out the form appropriately.
- When in doubt about any questions of nationality the form asks about, write “Pakistan.”
- Also, if you don’t know an answer to a question or are unsure, try to make an educated guess. In this sample, we guessed our answers in the following steps
- There are some parts of the application that might not be obvious. We have tried to explain how to navigate those parts in this document. For example:
 - Part 1: CKGS Initial Application:
 - Step 2(H): One question asks about your current and previous nationality. If you have never had a different nationality, this step can be confusing. You should put your current nationality as your previous nationality and
 - Step 2(I): The form asks you if you have renounced your Pakistan citizenship. If you select NO, the form will not allow you to go forward. We told them that many Ahmadis do not wish to renounce their Pakistani citizenship because they love Pakistan. In light of this, the Indian embassy and CKGS authorities have advised us to answer YES to this question and attach a notarized affidavit stating that you do not currently have a valid Pakistan passport and they consider that affidavit to be sufficient for this question.
 - In Step 2(K): This asks you if your parents are of Indian origin. The answer here should be NO since your parents moved to Pakistan from India after 1947. It is irrelevant if your parents lived in India before 1947 or before migrating to Pakistan.
 - Part 2: Indian Government Online Visa Form:
 - Step 5: One question on this screenshot asks whether your paternal or maternal grandparents were ever Pakistan nationals or belonged to a Pakistan held area which includes Pakistani Kashmir and Bangladesh before 1971. Even if you are not sure about where your grandparents lived, please select YES and give generic details like "my grandparents died in Pakistan" etc.
 - Part 3: CKGS Final Application:
 - Step 3C: One question on this screenshot asks whether the applicant or any of his grandparents ever held Pakistan citizenship, NICOP or Pakistan Origin Card (POC). You will select Pakistan and it will start asking you to enter information such as their Passport number, date they became a citizen and date their citizenship ended. This requires you to guess this information because most people will likely not have this information. Please put in your best guess and if you have no idea, put any random number. CKGS has assured us that they will accept it.

- Step 10: In the Affidavit of Pakistani Origin, the form asks you to enter the full name of your maternal and paternal grandparents. If you do not know their official names, just write 'unknown'. The system will accept it.
- Sometimes, when you hit PROCEED at the very end of the initial CKGS application (Step 2V below), it disappears and does not generate a TEMP number and take you to the Indian government visa site. If that happens, just start over again. When you hit PROCEED, you should see the screen depicted in Step 3A which tells you that you qualify for a Conference Visa/3 months single entry visa. You should also get a confirmation email from CKGS with the Subject: Visa Application. This email contains a Temporary ID number that starts with 'TEMP'.
- When you fill out the Indian visa form using the CKGS and Government of India online processes, numerous ID's are generated at different stages of the application process. These numbers are important to remember:
 - The first ID number is called the Visa Application Temporary ID Number. It is a 17-digit number that starts with TEMP. This number is generated at the end of the initial CKGS application and is used to reenter into the final CKGS application (Part 3) if you are disconnected from the site. If you get disconnected, go to the home page of CKGS, select the Tab titled 'Retrieve Your Application'. You should get in the application again.
 - The next number you need to remember is the Web Reference number. This number is generated at the very end of the Indian Government Visa Application (Part 2) (Step 11). This number used to get into the Final CKGS (Part 3). You can also use the TEMP number above to retrieve your CKGS application. Try both numbers.
- There will likely be other areas where you might get confused or where our sample deviates a little from the screen that you see when filling out your own application. Do not get concerned and write down your best guess on the online application. If that still does not resolve the issue, you can call someone at the Jalsa Salana Qadian Support Team at 301.879.0110 and we will try to help. You can also call CKGS helpline at 516-206-1483 / 646-589-0088. Hours of Operations: 9.00 AM to 9.00 PM EST (Contact Center operates from Monday to Friday except on Public Holidays). They are very helpful and have helped many applicants in the past.
